### 7.3 Facilities (DC)

DC reported on a busy month and so a large amount of income had been generated. There has been a problem with leaking toilets (hall).

Hall has been hired for a New Year's Eve party and hosts have been advised that it needs to be over by 1am.

DC advised that there is a new hirer – Kwinana Camera Club who will use the Clubrooms on Tuesday evenings in 2017. Airbrushing continues on Wednesdays and Pin Stripes on Thursdays.

Mummy Fitness, currently in Honeywood, enquired about using the grassed area at the hall but have now decided not to move from their current location.

CoK Library (Brett) approached WPA to use the Clubrooms for their Toy Library one morning per month (no charge). They have been offered the use of a storage area also at no charge.

Honeywood Residents Group was given free use of the hall/club rooms to rehearse the choir for their carols.

Water tanks – Resource Centre – pump found to be leaking. LW has fixed seals. Water delivered.

# C BARNES moved that pre-approval be given to the Treasurer to pay the account (\$130) for the purchase of water. Seconded by L WHIDDETT. PASSED. (ACTION: AM)

Water tanks – Hall Even though two caravan clubs have been onsite the water storage in the hall tanks is adequate. Cisterns have been leaking in the toilets, whilst some have been fixed, one has been turned off until it can be fixed – may need a new cistern. (ACTION: RC/LW)

Water tanks – Pavilion – full.

Pump-out pit – red light on – CoK advised.

Biomax warning light on – CoK advised.

Problems with security system and smoke detector. Satellite Security called out to service system. Phone line to Pavilion found to be not working – Telstra advised and have now fixed.
