MINUTES OF THE MEETING HELD ON WEDNESDAY 16th July 2014 AT 7.30PM AT THE WANDI COMMUNITY CENTRE, 302 DE HAER ROAD, WANDI

2. WELCOME The President opened the meeting at 7.40pm.

3. CONTRIBUTIONS OF RESIDENTS/GUESTS

Shahan Hobson (Satterley) provided an up date as follows:

- 1) Events planned include 2 workshops being run (A) Sustainable garden project and (B) Winter cooking
- 2) Neighbourhood watch: Key contact numbers being distributed including local emergency numbers
- 3) Meeting with Wandi Landcare representative (Catherine Garlick) concerning a proposed revegetation program and night educational walk
- 4) Bush tucker garden: Opening Easter 2015
- 5) Proposed new park in Honeywood rise
- 6) Movie night (TBC)

Shahan introduced Honeywood resident representatives (Sally Scata & Martyn Read) who are in the process of establishing a new resident group. They wished to gain an understanding as to how to go about establishing a new group or operate as a sub group of the WPA. The following points were discussed

- 1) Understanding of how a sub group would work as part of the WPA President Wayne Tentori (WT) advised that there was no problem in setting up a sub committee under a separate Honeywood resident group. WT was mindful of specific unique local issues of the Honeywood estate against semi rural properties in Wandi. The WPA constitution allows for creation of a sub committee operating with two separate committees whilst working together for the benefit of the wider Wandi community
- 2) Rod Cocks (RC) raised that all sub committee members of the Honeywood resident group would need to be financial members of the WPA. They sub committee representatives would need to be elected by members of the WPA. Once the separate sub committee was established then a representative from the WPA would then attend the sub group to report back to the main WPA committee. All bank accounts would need to be controlled by the WPA (Treasurer) and the group would need to meet constitution guidelines of the WPA.
- 3) Sally Scata (Honeywood resident) raised that there had been a number of break ins /car damage and some anti social behaviour. In addition local issues of children's play ground, lighting in the park ,security issues, resident support group and maintaining bush areas were all topical subjects that they wished to discuss as a group.

- 4) Les Whiddett (LW) raised that these were similar issues some 25/30 years ago which brought about the WPA being established for local residents. There is strength under a common umbrella and Wandi will continue to grow with the new areas. The WPA has a history of working with the Satterley group even before the Honeywood development commenced.
- 5) Shahan Hobson (SH) raised that the WPA relationship with the Satterley group is working well and compared very favourably with other Satterley developments
- 6) Martyn Read (MR) raised that they will have their meeting and discuss the issues with their resident group and look at attending the WPA and likewise would like to have a WPA member attend their meetings in the future and look at the option of rotating committee members
- 7) Rod Cocks (RC) advised that it was important to note that a sub committee by it's nature cannot make decisions on their own without the majority approval of the WPA committee. An example of a sub committee operating within the WPA is the Landcare group.
- 8) Sally Scata (SS) raised her concerns for her members would be around decision making and access to funds without the WPA approval if they operate as a sub committee
- 9) Martyn Read (MR) sought clarification that they would need to be financial members of the WPA (All sub committee members would need to pay \$15 pa which includes the current landcare annual levy .The resident group would need to seek to raise a motion for the WPA to create a sub committee .The WPA would suggest Catherine & Henry Garlick as residents of Honeywood would be suitable representatives for the WPA as current financial members

Overall the discussion confirmed that the WPA would be supportive of a sub committee being established
