9.1 Discussion paper – Review of Representation – City of Kwinana

RP gave a brief overview of why the Ward system had been dropped in 2006. He has spoken with representatives of Casuarina-Wellard who expressed the view that the rural areas are not represented adequately as all the current Councillors live in the City.

RC wondered if there was any point in making any changes now with the move to amalgamate areas into Super-Councils.

It was agreed the JC will draft a letter expressing our view that the rural areas be represented by a rural Councillor. To be emailed to all for comments before sending.

9.2 Honeywood

CB noted that the recent community safety meeting called by Satterleys was very poorly attended by Honeywood residents.

LW advised that there was a good attendance at the recent Honeywood night stalk despite the poor weather.
