7. REPORTS

7.1 President: Nil

7.2 Treasurer:

Treasurer's report was circulated prior to the meeting. Bank balance as at 15/09/19 was \$75,881.07 Income received was \$809.50

- 1. Accounts with the auditor have now been reviewed and audit completed and certificate issued.
- 2.Treasurer advised that our new auditor, as a specialist in Tax (GST), has identified in his report a couple of areas of deficiency that had not previously been raised that are required to be addressed. His auditor's report will be presented at our upcoming AGM and will include a comment around his findings and tax treatment.

Going forward the following policy will be applied for payments:

- Where regular services are provided then an ABN is required to be included on the invoice. If it is not, then withholding tax should be deducted at the current rate of 47% prior to payment.
- If a one-off service is provided by an individual not for financial gain i.e. cleaning the hall, then an ATO 'Statement by a Supplier' form must be completed and provided to the Treasurer (these forms are valid for 12 months) prior to payment. Otherwise 47% withholding tax will be deducted prior to payment.
- If committee members are seeking reimbursement of costs incurred on behalf of WPA the original invoice should be presented (with no 'header' invoice attached). These reimbursements will not be subject to withholding tax.

3.Treasurer discussed position with auditor regarding the dust extraction system recently installed and the arrangement agreed to between the WPA Inc and the Woodturners association. He has supported our treatment that the Woodturners Association Wandi group can make a donation of \$10K to the WPA Inc to go towards covering the total cost of the new system and this will not attract GST.

Telstra phone bill of \$32.20 was automatically paid.

- 1. Water treatment pump warning lights /alarm activated with pump to be repaired
- 2. Dust extraction system: Tripped out (5) times registering an error code. Wood turners association convenor has issued an email concerning issue and inspection identified that the control cabinet is too small causing over heating and the sensor being activated shutting down the system. Matter has been raised with supplier and promptly fixed under warranty.
- 3. Jenny Marslen & Scott Forder(COK) confirmed they will be attending the centre on 19th October 2019 at 3.30pm for a site visit to review location of proposed new air conditioning system in the recreation area and to discuss logistics.
- 4. Lighting upgrade review to improve quality of light to allow fine wood working is being assessed for the Woodturners group.
